# Coos County Foster Care Group Meeting #1 – January 5, 2009 Salem, Oregon

### Timeline for this Project:

The group wanted to set dates as soon as possible to try to accommodate the Judge and Legislator visits

**Note:** Let's sort out which will have the most impact on helping this project safely reduce the number of children in Foster Care. I'm thinking there may only be a few that have direct affect on the final action items and that this group can realistically address.

#### Data:

The group then reviewed the most current data supplied by DHS. We had a DHS data expert, Maria, in the room to answer any questions the group had.

1. How are Native Americans defined?

- a. People self identify to the case manager and it was those statistics that were used.
- b. Used the 'self-identified' field
- c. <u>Action Item</u>: train the professionals how to better help people identify their ethnicity so it gets correctly recorded.
- 2. Unknowns Coos is down to 14.6% and that number still seemed high to the group.
  - a. <u>Action Item</u>: Need training for staff on how to have the conversation about racial or ethnic identity. This number should be able to be significantly reduced once staff is trained to ask the question(s) and get a more appropriate answer.
  - b. Action Item: Work with the families to get more accurate self-identifications
  - c. Action Item: Ask the DHS Central Office to run new statistics.
- 3. 329 children in care on 9-30-07 The group agreed that this could not be true. This number actually represents the mean number of children in care at least one day during Federal fiscal year ending 9/30/07. It is important to remember that there are all kinds of out-of-home care and this is not reflected in the data. This data does not count substitute care through hospitalization unless s/he was a dependent child.
- 4. Page 3 rate of placement into care. The question was asked if it is true that the rate of placement of children in care is significantly higher than the state average? The data expert, Maria responded with a yes and explained this is a consistent pattern for Coos. Maria explained that she did look to make sure that this wasn't the artifact of one or two large sibling groups taken into care.
- 5. Page 6 percent of children with relatives as first placement. Group members stated that Coos has really worked on practice in this area.
  - a. <u>Action Item</u>: Might want to explore how people around the state are dealing with assessing and certifying the relative placement.
  - b. <u>Action Item</u>: Might be a good place to go with the QSR (Quality Safety Review). Maria and Nancylee will follow up at break.
- 6. Page 7 is it really true that 2.1% of the kids in care were African American? But the year before, only .8%? Maria responded, yes. The group agreed that there are so few African American families in Coos County, that one large family coming into care would make a big difference.
- 7. Multiple ethnicities Maria *thinks* DHS used multiple ethnicities in the data analysis and she will check with Anna Cox. The group discussed the challenges of tracking multi-ethnicities because TANF regulations require one ethnicity be identified.
- 8. State-wide goals Maria emphasized the Casey goals are state-wide. It may not be possible to reach a Coos-specific benchmarks, particularly around disproportionality and disparity that are the same as Casey's state-wide. **Note:** DHS is wanting each county to create action items for each of the goals, so we will need to discuss this more and create Coos-based, realistic goals. Coos may need to look at the possibility of a disparity issue rather than a disproportionality issue and what might be goals.

## Prioritize Goals:

Each group member individually prioritized the six pre-determined DHS goals. The group then discussed the goals and reached the following conclusion for the priority order.

- 1. Increase relative placements.
- 2. Reduce those entering care
- 3. Reduce recurrence of abuse with particular attention to those returning home
- 4. Increase the number of exits
- 5. Reduce disproportionality

## **Discussion on Goals:**

The group then began the discussion on specific actions and/or strategies to address each goal. We were cut short in the discussion by 45 minutes so the group only strategized some solutions for the first goal.

- 1. Increase Relative Placements.
  - Currently (FFY '07) Coos is at 20% in kin
  - The current Waiver Plan goal is to have 20 kids with families by June 2009. To date there have only been found 4 families found.
  - The group talked about how this would need to look in terms of a benchmark and no specifics were determined, at this time.
  - Strategies:
    - 1. Use the IV-E Waiver funded projects regarding family dynamics
    - 2. Use the IV-E Waiver funded projects regarding relative search. Currently there is one FTE allocated to this work and it has not been very successful. Go back and look at all the things this person is doing and see if there is a way to support her success.
    - 3. Seek technical assistance from Casey on how to make this successful.
    - 4. Identify barriers (example: need financial support, day care, certification barriers addressed)
    - 5. Ask Casey whether there is going to be any action at the federal level to change the certification requirement in IV-E around licensing.
    - 6. Definition change to include kith and kin placements.
    - 7. Consider a state policy change that face-to-face contact, which might include video conferencing.
