BRIEF MEETING SUMMARY

National Forest Health Restoration Economic Assessment – Status

A meeting was held this morning at the Mason, Bruce and Girard offices (8/2) with representatives from collaboratives to review and discuss some of the assumptions being used to demonstrate the economic impacts of increased restoration. The consultant team is working with a broad base of forest experts from academia, industry, government and community based natural resource management organizations to inform work including a peer review panel.

<u>Budget Proposal – Support for local collaboratives</u>

Originally proposed as a policy option package, it is likely that the budget proposal will instead be presented in the jobs and economy funding subcommittee. The proposal has 3 major components as follows:

1. Staffing – Deputy Natural Resources Advisor for East Side National Forest Health Restoration



- 2. Technical Assistance Provision to fund statewide organizations that support forest collaborative groups to effectively participate and contribute to landscape-scale restoration in the Dry Forest Zone of eastern and southwest Oregon
- 3. Small Grant Program Establishment of a Small Grant Program to directly fund DFZ collaboratives' own needs

The proposal is framed with an understanding that there will be larger investment (a "big" dollar ask) needed for USFS to implement collaborative supported treatments.

There was a lot of discussion about how supporting collaboratives can only accomplish so much without staff capacity and fundamental organizational changes internal to USFS in order to implement restoration goals agreed upon by collaboratives.

O&C Lands Update

Tom Tuchman with the Governor's Natural Resource Office has been meeting with stakeholders over the last 60 days in Oregon and D.C. to understand challenges and opportunities around O&C lands. A major issue is developing forest management activities that are acceptable to a broad representation of stakeholders while providing certainty to the timber industry as well as counties about expected timber sales. The state is still developing the process to engage with community and organizational stakeholders over the next 6 months to develop a resolution in early 2013 that addresses current challenges.

Mark Brown from BLM provided a brief update on the six Western Oregon Resource Management Plans under revision. The scoping period ended July 5th and BLM is committed to an open, transparent planning process with full public input and comment opportunities. Thus far FFAC IWG has kept the federal lands discussion separate from O&C lands though many participants are interested in being involved in future discussions and a submeeting may be scheduled for more information. The Atlas provides an overview of the conservation values supported by more than 2.4 million acres of public lands managed by the Bureau of Land Management (BLM) in Western Oregon.



Collaborative Forest Landscape Restoration Program—Work session

CFLRP awarded two forests funding in 2010; Deschutes Skyline and Tapash. There has been some frustration around these projects in delivering timber harvest as neither had a lot of "NEPA ready" acres for treatment.

2012 recipients from the Deschutes, Fremont Winema and Malheur National Forests provided information at the meeting about opportunities and challenges they face in meeting the goals set forth in their proposals. Some common challenges included:

- The lack of funding for planning and capacity development
- Major capacity issues within the Forest Service to balance programs
- The restoration needs for our lower elevation federal forestlands have found a high level of agreement through the collaborative process. Generally, these lands have or are being addressed in the USFS planning process and associated management activities on the dry Federal Forests. However, these forests are faced with more difficult management decisions to build consensus around as many stands are more complex than the low elevation dry forests characterized by pine and related plant communities (e.g. higher elevation, different plant association groups).
