DRAFT Wallowa Resources Sustainable Forest and Wood Products Project Declaration of Cooperation

October, 2001

WHEREAS, Wallowa Resources was created by the community of Wallowa County as a non-profit organization to provide leadership in sustainability by promoting community, forest and watershed health and creating and maintaining family wage jobs and businesses; and

WHEREAS, past management practices and climatic conditions in the forested landscapes of the Northwest have contributed to a decline in forest health resulting in a majority of small diameter trees that are easily subject to catastrophic fire, disease and insect infestation; and

WHEREAS, the reduction in forest management activities on public lands has resulted in the loss of nearly 400 jobs in the wood and lumber manufacturing sector of Wallowa County's economy and unemployment has continued to increase over the past decade with current figures nearing 20%; and

WHEREAS, there remains a strong desire within the community to continue a natural resource-based economy based on sustainable land management practices that provides economic benefits to the community, both in terms of forest management activities and value-added manufacturing opportunities; and

WHEREAS, enhancing Wallowa County's economy, creating community viability and restoring the environment requires unprecedented, committed, multi-party partnerships between federal, state, local, non-profit and business; and

WHEREAS, Oregon Solutions are community-based projects in Oregon that simultaneously support the economy, environment and community and are developed through the collaborative efforts of business, government agencies and citizen organizations; and WHEREAS, the partners in this Declaration of Cooperation agree that the Oregon Solutions framework is perfectly suited for demonstration in Wallowa County to engage local and external partners in helping local landowners and managers achieve sustainably managed and restored forests and local manufacturers find niche market opportunities and in identifying and providing training, technical assistance and capital resources to implement the community's vision; and

WHEREAS, Wallowa Resources, agencies, organizations, local mills, landowners, land managers and individuals are willing to make commitments to forest health restoration and diversification; now

THEREFORE, THE UNDERSIGNED AGREE TO PARTICIPATE AND SUPPORT THE WALLOWA RESOURCES SUSTAINABLE FOREST AND WOOD PRODUCTS PROJECT PARTNERSHIP, AS FOLLOWS:

Wallowa Resources

Wallowa Resources administers a number of programs that have the potential to support the project and the partnership. Wallowa Resources provides technical and financial assistance to private landowners, public land mangers, and local businesses including Joseph Timber Company. This assistance is provided in a variety of forms, for example: conducting market research on brokers, wholesalers and retailers of certified and small diameter wood products as well as product types and prices paid, arranging and hosting a scooping visit for private forestland owners conducted by SmartWood in November 2000, and facilitating the chain-of-custody certification of Joseph Timber Company issues by SmartWood.

Wallowa Resources is committed to continued assistance in the following forms:

- Conducting certified and small diameter wood products market research, product development and product promotion in cooperation with regional advisors
- Developing and adopting an organizational structure for the Wallowa landowners certification association

- Providing expert information on the kinds of cooperatives and associations of limited liability corporations best suited for group certification and group woods marketing arrangements
- Developing a business plan for certified and small diameter roundwood products designed to create sufficient value-added profit to fund private landowner certification costs
- Furnishing information on innovative types of wood marketing arrangements between groups of Forest Stewardship Council (FSC) certified landowners and local mills such that some consistency of supply for mills and just prices for landowners is achieved
- Sponsoring continued audits of certification association landowner forestlands
- Identifying expertise to develop forest management plans required for certification and/or conducting necessary surveys e.g. T & E, Stand Structure, Cultural Resource, Riparian Condition
- Networking between the state's forest landowner groups to share innovations in this field as they are developed
- Funding and staff time (\$10,000) through existing and new grants

Wallowa County

Wallowa County has the ability to assist the project in a number of ways.
