Convener Deputy Fire Chief John Nohr welcomed the group with a personal anecdote about the need for safer highway incident management in the State of Oregon. Participants introduced themselves and briefly described their interest in this project.

Jessie Conover (Oregon Solutions) explained the role of the Oregon Solutions program in this process and the timeline for Oregon Solutions involvement through September. She described the purpose of the kickoff meeting: 1) to bring together a multidisciplinary and statewide group of incident response leaders 2) introduce the training material 3) answer questions 4) obtain commitment to the implementation committee and 5) identify gaps in representation.

## Training Overview (FWHA)

Jocelyn Lewis (FHWA) presented the training development process, the partners involved, and the training objectives. She also reviewed some sample slides from the four-hour training.

#### Discussion:

- The Train the Trainer program and supplies are provided by FHWA at no cost. The materials are available electronically. Other state implementation committees have figured out how to deliver the training to students; the cost of student materials is low.
- There was some concern about how the training program could be implemented sustainably, especially when handed off to the state.
- In response to a question about an online version of the training, FHWA
  explained that there is an online version under development, expected to
  be ready within a year.
- The 12 hour Train the Trainer session is 8:30am 4:00pm on Day 1 and 8:30 12:00pm on Day 2. It cannot be compressed into a single 8-hour day.

#### State Implementation Perspective

Frank Horne of the Tennessee DOT presented his experience since Tennessee started implementation one year ago. Tennessee formed Traffic Incident Management (TIM) committees and developed memoranda of understanding (MOU's) to support the spirit of cooperation between everyone involved in highway incident management. The Tennessee program has been sustainable because of high-level leadership and buy-in from organizations with a keen understanding of the need for safer highway incident response. Frank impressed upon the group the value of doing multidisciplinary training to understand the needs of other incident response groups. The module format provides a flexible framework for training delivery.

Frank identified several keys to success in Tennessee: 1) regularly scheduled training events 2) include all stakeholders 3) MPO involvement and leadership 4) agency designated partnerships 5) interagency communication plans, exercises, and training 6) integrate intelligent transportation systems (ITS) components and 7) instructor commitment.
