

May 9, 2015 FFAC-IWG Meeting: Action Items and Updates

- Federal/State Business Partnership. Brett discussed the proposed new partnership model in more detail and offered to share the conceptual schematics that Chad Davis has been working to capture for clarity and more discussion. Two schematics are attached. Note the Partnership model is more relevant to the Governor's Recommended Budget discussions. The Biz Model version is more general use.
- Stewardship contracting reauthorization: Moving forward in the Farm Bill. Senate Agriculture
 has passed their Farm Bill which includes a clean (no changes from current authority)
 permanent authorization of Stewardship Contracting. After the Chairman's mark in House
 Agriculture, Stew Contracting sits currently as a clean 5-year extension on that side. More
 information will be available at the June meeting.
- USFS Region 6 budget: The Regional Office is expecting to receive a final budget on 5/10 for the current Federal Fiscal Year ending 9/30/13. Expected to include \$4.6M extra for the Region out of the Chief's focused funding allocation.
- USFS staffing: Jeff Walters is on assignment as the Deputy Regional Forester until 6/30. Kate
 Klein will be the acting Natural Resources Director. Tracy Beck and Debbie Hollen will be
 switching their assignments during this time as well. It's hoped that both Kate and Debbie will
 be able to attend our June meeting.
- Malheur 10-Year Stewardship contract: "New, never been done before". # staff in RO are
 working on the contract development. Technical workshop still on track for June, exact date
 TBD. Selection committee will also be identified in June. Randy Gould is the MNF point
 person for the contract. Expected to be an IRTC that adds tasks/volume in later years.
- Mill Creek A-Z, Okanagon NF. Project out for solicitation (an IRSC project).
- Blues Project: Bill Aney expects vacancy announcements out in the next week "or so", after Malheur NF announcements are completed. Will be working to identify areas for \$200k additional LIDAR to be flown in the Blues,to add to existing data. "Coalition of Collaboratives" formation underway. Steering Committee to include representatives from each of the existing 5 collaboratives. County Commissioners to initially convene the coalition, tentative date is June 11. Will follow up with OWEB to understand former and ongoing efforts to build regional coalitions from local watershed councils to apply lessons learned to the forming Blues Mountain Collaboratives Coalition.
- SB 357: SB 357 has passed the Oregon Senate. House held public hearing this morning (5/14). Public testimony was sparse but only on supportive side (Senator sponsor, Gov Office, ODF, Bill Kluting). Kevin Birch, Chad Davis and Pete Dalke will work with Brett to further refine the expectations about staff time, budget and work products embedded in SB357, and to begin shaping the FFAC-IWG's work plan going forward that will be informed by the bill.
- Performance metrics related to the Governor's Dry-Forest initiative. Nathan Poage will
 continue analyzing data from the Malheur NF in the USFS databases (PALS, FACTS, TIMS) to
 inform baseline and trend performance measures. Curt Qual and Nathan will work together to
 provide more information about how collaborative participation was defined for replication of
 similar analyses on other dry-side National Forests.



- Collaborative networking: Patrick Shannon will share summary feedback from surveys and evaluations completed at the CFLRP network meeting in Hood River. Next steps for networking to be discussed at the June FFAC-IWG meeting.
- NFF Community Capacity and Landscape Stewardship grants: expect award announcements in June.
- Board of Forestry 7/25 meeting in LaGrande. ODF and the Governor's Office will be coordinating on the agenda, and a panel presentation from the FFAC-IWG may be included.
