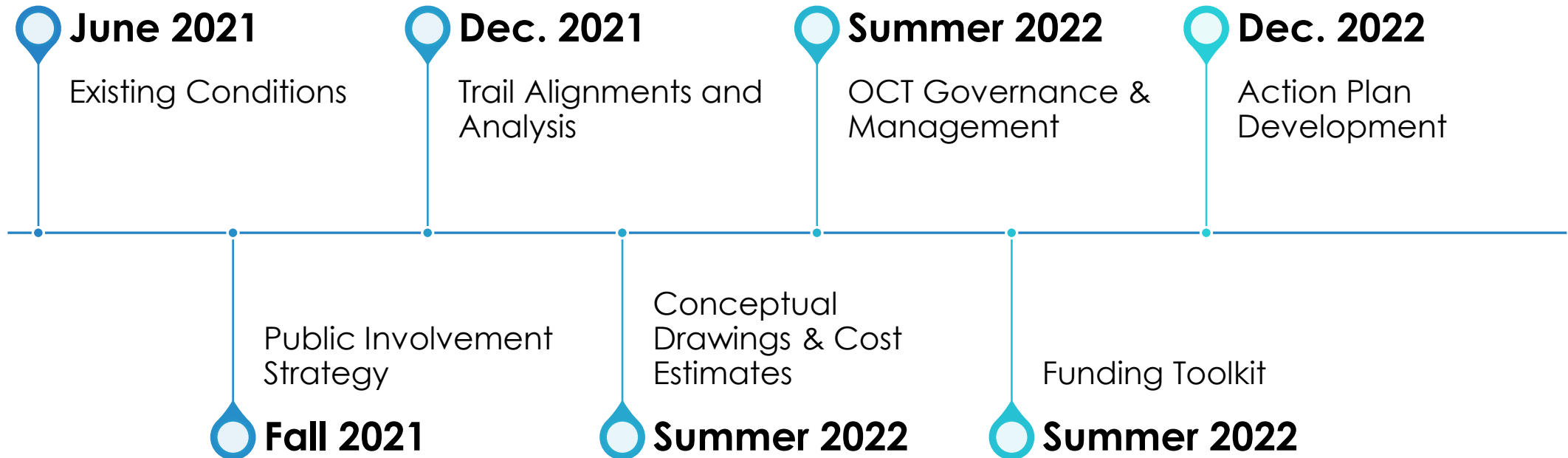

Timeline

Each Segment Team will meet twice (once after completion of the first round of Connection Team meetings and once after completion of the second/final round of Connection Team meetings)

All Connection Team & Segment work to be completed by December 2021

Collaborative Model Tasks

Convene local stakeholder meetings to ensure trail alignments and related considerations are developed out of robust local engagement and consensus-based decision making for specific trail alignments

Provide facilitation, scheduling, and other meeting logistics

Lead development of Declarations of Cooperation (one per Connection Team & one for each Segment Team)

Utilize the "Association of Oregon Counties Procedures Manual Creating a Neutral Forum for Collaborative Problem Solving" for this work

Utilize this same collaborative model for the OCT Statewide Landowners Group
