

Declaration of Cooperation Vernonia Schools Project

June 24, 2009

Background

On December 3, 2007, the city of Vernonia, Oregon, suffered the second "500-year flood" in eleven years. A combination of heavy rain on top of snow caused the Nehalem River and Rock Creek to overflow their banks and flood much of downtown Vernonia. Nearly 300 people were rescued from homes and workplaces, and there was widespread damage to private property, businesses, and public infrastructure.

District Superintendant Ken Cox had closed schools for the day so no children were present at the time of the flood, but all three schools and the district office were hard hit, and the high school was substantially destroyed. Following the flood, Vernonia's nearly 700 students were sent to classrooms around the community and to schools in Scappoose. In early February 2008, the elementary school and middle school buildings were re-opened. Children from all grades are attending school in a combination of the two buildings and modular units, but the situation is still a makeshift one: The high school is unusable and has been mostly demolished. In addition, the elementary school is in bad state of repair and has a significant collapse potential in case of an earthquake.

Soon after the flood, the Army Corps of Engineers issued and the City of Vernonia adopted a new floodplain map, placing all three schools squarely in the high-risk zone for future floods.

After the immediate recovery efforts were underway, the town decided that its first and highest priority was to rebuild a safe and sustainable school system out of the newly mapped floodplain and harm's way.

Oregon Solutions Project

In April 2008, Governor Ted Kulongoski granted Columbia County Commissioner Tony Hyde's request to designate the Vernonia Schools Project as an Oregon Solutions project. Governor Kulongoski responded: "This project is important to me and my staff. The problem of relocating and funding Vernonia's schools needs to be addressed immediately. Education is one of my highest priorities and with that comes the need to provide our students with a safe and healthy environment in which to learn."

The Governor assured participation of his staff and appropriate state agencies on the team. The project team has met for over a year and has achieved its first goal: to find a new site for the school system and to get the appropriate land use documentation prepared for filing. This declaration of cooperation is designed to document the successes of the project to date and to outline the next phase of collaboration.

Agreements

All team members acknowledge that the best solutions depend upon cooperation by all entities at the table. Accordingly, they recognize that each individual has a unique perspective and contribution to make, and legitimate interests that need to be taken into account for the success of the various projects. The following sections provide each entity's contributions to the project listed above.

Purpose of Declaration of Cooperation

Oregon Solutions provides a structure for the public, private, and civic sectors to collaborate in addressing one of the state's sustainable community objectives. That collaborative process, which results in agreements being made between the parties and commitments being made to the project, created the basis for this Declaration of Cooperation. This document outlines the commitments that all parties have made to successfully carry out the project and to achieve their collective goals in Phase II of the Oregon Solutions process.

Collective Project and Achievements

For over a year, the Oregon Solutions team, representing federal, state and local government, private industry, civic organizations, and philanthropies, has met to support the Vernonia School District and the City of Vernonia in their efforts to find an appropriate location for the Vernonia school system and to assist in any land use applications that might need to be made. The team has leveraged hundreds of thousands of dollars to the project and has engaged the businesses, regulatory agencies, and the public in the process.

The next phase of the project will be focused on finding funding for the school project and for supporting the entire community in making connections between the overall Rebuild Vernonia efforts and the reconstruction of the school system.

City of Vernonia

The City of Vernonia (City) is represented on the Oregon Solutions Project Team by Interim City Administrator Jim Johnson and by Planning Commission Chair Dan Brown. In the spring of 2008, the City agreed that the school rebuilding process should be one of the highest in the flood recovery effort and agreed to serve on the Oregon Solutions team assembled by the Governor. The city administrator served on the Executive Committee and the Siting Committee and Planning Commissioner Brown was the chair of the Siting Committee. The City and the School District have worked cooperatively with the other partners to find mutually satisfactory solutions to siting a new school complex.

The City has a variety of roles in the siting process: 1) the City owns land that is suitable for the new school and is within the preferred site recommended by the Oregon Solutions team and selected by the board, and the City is willing to negotiate a transfer of this land; 2) the City's roads and utilities will serve the new school; 3) the City provides permit services for the new school; 4) the City and Columbia County have jurisdiction over land use issues which will include the processing of an urban growth boundary amendment; and 5) the City supports the new school as a vital community facility necessary for a thriving city.

Because of the importance of the new school to the community, the City of Vernonia commits to the following:

- The City Administrator and the Planning Commission Chair will continue to serve on key committees organized to support the Oregon Solutions Project.
- The City will give priority, within city laws and guidelines, to the issuance of permit applications for any school-related project.
- As land owner of Spencer Park, which is a potential school site, the City will work with the School District on an exchange of property that will replace inkind the park facilities built with volunteer labor and federal and state grants, on a site now owned by the School District.
- As desired by the School District, the City will negotiate an agreement for the use of the city's 50+ acre forest property as an educational "classroom" for Vernonia School District students.

- The City will work in partnership with Columbia County to expeditiously process an Urban Growth Boundary Amendment to include school property within the city limits.
- The City agrees to consider an amendment to the city's various Systems Development Charge (SDC) ordinances so that if the School District (or any other owner) can show that there is no new net gain in demand on a utility system, then the cost of that utility SDC will be reduced. For example, if all stormwater drainage from the school district's property is handled on-site, then the city will agree to significantly reduce the stormwater SDC.
- The City will work with the School District to plan the vehicle, bicycle, and pedestrian transportation routes to and from the new school.
- The City will join with the School District to apply for state and federal grants to support the construction of the new school complex, transportation improvements, and the extension of utilities.
- The City will work with the Oregon Solutions Project Team on balancing congressional funding requests between city needs and Oregon Solutions priorities.
- The City will work with the Oregon Solutions Team in the next phase to develop an integrated set of projects to support Vernonia in its efforts to become a more sustainable and prosperous community as part of an effort called *Rebuild Vernonia*. In addition to new schools, key projects will include a new sustainable wastewater treatment facility, a new headquarters building for West Oregon Electric Cooperative designed to at least a silver LEED standard, a Main Street and urban renewal program downtown, construction of a Recycling and Reuse Center, and the development of a light industrial park, including a new power generation plant that would convert biomass to electricity.

Winterbrook Planning

When it became clear that one possible site for a school complex was located outside of the city's current Urban Growth Boundary (UGB), staff from the City of Vernonia and from Oregon Solutions approached Greg Winterowd, a principal in the firm of Winterbrook Planning. Greg provided technical assistance to city and Oregon Solutions staff about the details of an UGB boundary expansion under Oregon state law. He also talked to DLCD staff and met with them to determine the best approach to a UGB expansion application.

Winterbrook Planning agreed to complete the application to Columbia County for a UGB expansion amendment. This application has been submitted to Columbia County and to the State Department of Land Conservation and Development. The application was completed by Jesse Winterowd and Greg Winterowd at no cost to the city.

The UGB amendment process includes hearings before the city planning commission, the county planning commission, the Vernonia City Council, and the Columbia County Board of Commissioners.

Winterbrook Planning commits to continue providing technical assistance to the city as the UGB application goes through the approval process. The firm also commits to meeting with the city/county and staff from DLCD if that is necessary.

Columbia-Pacific Economic Development District (Col-Pac)

The Columbia-Pacific Economic Development District (Col-Pac) is represented on the Oregon Solutions Project Team by William Haack, Economic Recovery Manager. The Col-Pac is a private non-profit organization established to assist in diversifying and strengthening the economy and livability of Northwest Oregon. The District covers all of Clatsop, Columbia, and Tillamook counties and the western part of Washington County. Col-Pac secured an U.S. Economic Development Administration (EDA) CAPACITY BUILDING GRANT that fully funded this position in 2008 to 2010, a total of \$150,000 combined. In addition, the EDA grant was expanded in 2009 to support a LIDAR imaging survey of Colombia County to in part assist the school siting studies, an assessment of properties zoned light industrial that may be used to locate critical services out of the flood plain, and to analyze the opportunities to bring high-speed internet connectivity to the new campus and the community as a whole. The value of these three services to the community is \$80,000. To date Haack has served as the Hazard Mitigation Grant Coordinator for Columbia County, assisted the school secure an initial \$75,000 grant from the Ford Family Foundation, prepared work sessions and town hall meetings this past year to assist the community grapple with the issues that they are facing since the December 2007 flood event, served on the Oregon Solutions Project Team, the executive committee, the Budget Committee, and the Development Committee.

In 2009 and continuing in 2010:

- Col-Pac will fund elements of the LIDAR mapping contract, specifically as they pertain to the
 greater Vernonia area of interest, and serve as project liaison with the Army Corps of Engineers
 and the State of Oregon
- Col-Pac will convene and attend meetings with WiMAX and other high-speed internet technology
 firms to assess their viability in a remote rural environment to support communities, businesses
 and schools; and Col-Pac will meet with USDA and DOC to assess which Federal broad band
 component of the Recovery Act is best designed to work in Vernonia
- Col-Pac will assist the City of Vernonia manage the development of a multi-use facility to locate
 the senior center, food bank, and health clinic; this will include coordinating the transfer of
 surplus lands from the State to the City as well as creating and leading a development and
 financing plan for the site and improvements
- Col-Pac will provide staff support to research the use of woody biomass generation as an element of the school and the City's community-wide recovery efforts
- Col-Pac will meet with Federal congressional staff and assess whether the needs of the community can be served by high level intervention for the Project
