Oregon Solutions Process: Oregon Solutions (O/S) is a program of the National Policy Consensus Center at Portland State University. The mission of Oregon Solutions is to develop solutions to community based problems that support sustainable objectives for the economy, the community and the environment and are built through the collaborative efforts of citizens, businesses, government and non-profit organizations. The O/S approach integrates and makes efficient use of public and private investments, elevates the visibility of the project and engages communities in creating solutions. The process provides a neutral forum — a place where various interests and stakeholders can come together as parties in a "Project Team," in a manner that is more neutral than a meeting sponsored or hosted by one of the parties at the table.

Purpose of Declaration of Cooperation: Through the Oregon Solutions process described above, collaboration among parties on the Project Team is anticipated to develop and evolve as the process continues, with the intent to foster or facilitate agreements amongst the parties about which potential actions, or suite of potential actions, may be taken to cumulatively lead to successful project outcomes, including preliminarily identifying which party may be appropriate to take specific potential actions, how and when. This collaborative work product is documented at the end of the O/S process in the "Declaration of Cooperation," which can be understood as a non-binding *implementation plan*. The Declaration, including the stakeholder commitments, is considered to be a "living" document that shall continue and may evolve with the opportunities for parties to amend by unanimous consent from time to time, to represent changing situations often found during project development, until project completion or until suspended by mutual agreement.

Background to Project: In September 2013, Oregon Parks and Recreation Department (OPRD) will open the state's newest, and eventually the largest, state park. Cottonwood Canyon State Park is located along the Lower John Day River, between Sherman and Gilliam Counties, and will be a unique addition to the OPRD system.

In early 2011, OPRD joined in discussions with the Lower John Day Conservation Collaborative (LJDCC) regarding an "education and interpretive" center to be located at the park. The vision for the center included museum-quality conservation, historical, and cultural programming, educational facilities and print materials about Cottonwood Canyon State Park and the surrounding region. Both entities describe the education/interpretive center as an opportunity to create a "gateway" to the John Day River and the four counties it occupies. From this "gateway," students, tourists, residents, and technicians could learn about and conduct research in the high desert and the John Day Basin.

Between the LJDCC and OPRD, there was recognition for assistance with capacity and bringing together multiple participants from the community to ensure that a center would provide not only useful information about the Park, but would also tell the story of those who have been an integral part of the Lower John Day Basin and the surrounding community.

In July of 2011, the Association of Oregon Counties (AOC) jointly with OPRD submitted a request for consideration as a designated O/S project. Based on the potential scope, cost, and diverse interests involved, Oregon Solutions was seen as the ideal forum through which to bring together the diverse interests and lay out an implementation plan for the center. In November 2011, Governor John Kitzhaber designated the project as an Oregon Solutions effort and selected AOC Executive Director Mike McArthur and former Gilliam County Judge Laura Pryor to be co-conveners.

The project team had their kick-off meeting in Moro on March 20th, 2012. A list of project team members can be found in **appendix A**.

Project purpose & vision: The O/S project team came up with a purpose statement which helped to guide the discussion and subsequent commitments. The statement is as follows: *To work collaboratively towards a proposal for the programming, facilities, infrastructure and governance of an educational experience center for all ages based at Cottonwood Canyon State Park, which incorporates the values of the community and region including the natural history of the John Day River Basin.* This will be accomplished within the provisions of the Comprehensive Government Management Plan (2001).

Achieving the Vision: Achieving the vision above will require the commitments of all parties as identified later in this document. These commitments and this Declaration of Cooperation

signify the substantial completion of the Oregon Solutions process. However, the success of the Cottonwood Canyon State Park Experience Center project will require an ongoing collaborative effort and the continuation of a *Project Implementation Team* to coordinate ongoing commitments and to provide on-going community-based support and information to the parks department, to be known as the <u>Cottonwood Canyon Community Coordinating Council ("C5")</u>. As a group of community leaders and stakeholders, this group will provide insight and connections to members of the community, and reflect the values and interests of those communities in discussions with OPRD. It is recognized that the C5 is not a decision making body, but is expected to provide feedback and direction to OPRD. Membership in C5 is completely voluntary, and membership is obtained through self-selection. Administrative management of C5 is anticipated to be minimal, with coordination of times and locations for meetings, and distribution of meeting materials. The C5 will meet bi-annually, with additional meetings as needed. Agreements to participate in the C5 are included in the stakeholder commitments.

This Declaration of Cooperation, while not a binding legal contract, is evidence to and a statement of the good faith and commitment of the undersigned parties. The undersigned parties to this Declaration of Cooperation have, through a collaborative process, agreed and pledged their cooperation to the following findings and actions:

Dear Lauren,

As we have discussed, Western Rivers Conservancy wishes to contribute to the Declaration of Cooperation with a specific proposal the fits our current role and activities on the former Murtha Ranch, which is now Cottonwood Canyon State Park. Upon completion of our activities related to restoration and monitoring, our active participation in the State Park will end. However, in the next several years we feel we can provide guidance, mentoring, and opportunity in efforts to bring children to the park for resource related activities and environmental education. Following is a synthesis of the initial proposal we made in August .

Proposal: Monitoring and Implementation of Restoration Efforts Directly Involving Local Schools

Western Rivers Conservancy (WRC) purchased the Murtha Ranch in October 2008. Located along the Lower John Day River between Wasco and Condon, the property was comprised of about 8000 acres of fee title land and was intermingled with over 8000 acres of BLM land. The property straddled both sides of the Lower John Day River and included roughly 16 miles of shoreline. In October of 2011 Oregon State Parks and Recreation (OPRD) completed purchase of the property from WRC and committed to opening a new State Park in 2013 to be called Cottonwood Canyon State Park.

While the property was in WRC ownership, there were extensive efforts to initiate noxious weed control, control livestock grazing in riparian areas, restore riparian habitats, and restore former agricultural fields to desirable conditions. Efforts included hundreds of acres treated with herbicides to control noxious weeds in cooperation with local agencies, thousands of trees and shrubs being planted to encourage restoration in key riparian habitats, reseeding former agricultural fields with desirable grasses, removal of woven wire fences that inhibited big game movement, and halting livestock grazing



for the time being. The focus of these restoration efforts was on the lower three miles of Hay Creek, a small but important and unique cold water tributary that supports the spawning and rearing of wild steelhead.

Concurrent with these Oregon Watershed Enhancement Board (OWEB) and Oregon Department of Fish and Wildlife (ODFW) funded restoration efforts was the initiation of a basic monitoring plan funded with another OWEB grant to document the success of recovery efforts. The focus of the monitoring is largely qualitative and includes water temperature and flow, survival of planted vegetation, success in controlling noxious weeds, numerous photo points, and aquatic insect sampling. The grant for this monitoring ends in December 2014.

WRC contacted Arlington High School and on three occasions students participated in planting and monitoring efforts in fall and spring. Generally 15-20 students came to the site for a day. This experience with student involvement in WRC activities formed the basis for our proposal to the Committee. During discussions of the Cottonwood Canyon Education and Interpretive Committee, the issue of educational involvement via" hands on" experiences with schools has been strongly supported. The presence of a State Park within 40 minutes of Condon, for example, makes its use as an "outdoor educational center" easy to visualize. Given the current status of education budgets any new program will likely be difficult to launch without new funding.

Specifically, WRC proposes to assist the Committee, or a subset of the Committee, in the preparation and submittal of a grant proposal that would continue and expand the existing monitoring efforts in Hay Creek and other points along the main river and include a stronger education component. Key elements in the proposal are:

- 1. Proposal to be submitted by Condon School District/Sherman County School District and, possibly, in partnership with the local watershed district and the SWCD.
- 2. The proposal would add new areas to the monitoring "footprint"; specifically the upcoming CREP project just below Cottonwood Bridge and , potentially, a new restoration effort on the riparian areas just above and below Cottonwood Bridge (this proposal has been submitted to OWEB and initially funded). These would be proximate to the Center planned for construction at Cottonwood Canyon. Hay Creek would continue to be included.
- 3. The proposal would add a new wildlife element to the monitoring; specifically the monitoring of birds. Birds are among the best groups of wildlife for monitoring because they are visible, vocalize during many seasons of the year, can be captured and handled relatively easily, and respond quickly to habitat changes. Birds are also extensively monitored across the United States and a new effort in Cottonwood Canyon SP would be benefitted by existing studies, data and groups/agencies engaged in avian monitoring.



- 4. WRC has had initial discussions with several avian groups that are interested in participating in educational efforts as part of monitoring and would bring expertise, equipment, and, possibly financial support/matching funds to a proposal for Cottonwood Canyon.
- 5. The monitoring proposal "horizon" would be for at least a decade and, hopefully, would establish what would become a continuous effort with a strong educational component and multiagency funding that assures stability.

Summary:

WRC would assist in the development of a proposal to OWEB and other funding sources to continue and increase student involvement in monitoring efforts on the Cottonwood Canyon State Park with a heightened emphasis on the educational component and inclusion of numerous partners to bring expertise, equipment, and , potentially, financial support. This proposal would build upon existing monitoring efforts in Hay Creek and include that site in future monitoring.

Unlike governmental agencies that will have a perpetual relationship with the new State Park and local residents, WRC will move to other projects once our role on the former Murtha Ranch is ended. Therefore, we feel this type of proposal is more in keeping with what we can bring to the larger effort in building a long term relationship between the new State Park and the enormous opportunity that it presents for the involvement and enrichment of students and residents in the local area.
